- Students in grades 3 & 5 participate in the New York State English Language Arts (ELA) and Math Assessments each Spring. Grade 4 students take the New York State Science Exam each Spring. In 2021, NYS tests were modified due to Covid-19.
- Faculty includes a STREAM teacher, Spanish teacher, art teacher, music teacher, physical education teacher, speech teacher and counselor (PT through Catapult Learning).
- Collaboration with the Saratoga Springs City School District to provide special education services and related services to students



## **Finances**

- Annual report sent to Catholic School Office
- Volunteer finance committee advises the Principal and Pastor on financial matters related to the school's budget, spending, financial planning, tuition and fees, and overall fiscal status
- Committee meets periodically and reviews/monitors budget and variance reports which are distributed at monthly School Board meetings
- Finance committee is chaired by a member of the School Board. Members have various expertise in finance, budgeting, and other fiscal areas.
- The COVID-19 pandemic greatly affected our finances by reducing revenue as tuition collected decreased and fundraising was put on hold. Families affected by the pandemic had their income reduced as jobs were reduced or hours were cut. This prevented them from meeting tuition payments.




#### **DIOCESAN (SYSTEM) PLAN**

# Governance

- The purpose of the School Board is to act together with the pastor and the principal to assist in the governance of the school in accordance with the policies of the Albany Diocese. The School Board is an advisory board, so its function is to advise the principal in formulating policy to administer the school. The School Board will not administer, that is the responsibility of the principal.
- The School Board is composed of nine members.
- The committees of the School Board include: Catholic Identity, Finance, Facilities, Development, Enrollment/Retention, Curriculum, By-Laws & Policies, Elections.
- The School Board meets monthly with the exception of July and August.
- All are invited to attend School Board meetings. A schedule is posted on our website.

#### **Covid-19 Supplement**

When the Covid-19 forced the shutdown of our school buildings in March 2020, we faced many challenges. Emergency planning had not even imagined what this pandemic had created. In our society, everything shut down and fear and anxiety consumed many. Families were isolated in their homes. Parents were now working from home while also tending to their children who were forced to remain at home.

Amidst all of this confusion and uncertainty, our faculty remained focused on the children entrusted to them on a daily basis. They faced the challenge head-on and provided distance learning experiences to keep our students engaged. The learning curve was never a roadblock. Teachers, in addition, to meeting with their students daily, also were engaged in learning themselves, seeking training in on-line platforms and apps that would enable them to keep "the learning going." Google Meets allowed students to see their teachers and one another. As a faculty, we made adjustments so as to respond to the needs of our students. The school year (2019-2020) ended in an unusual way with drivethrough graduations and home deliveries by our teachers to recognize the accomplishments of our youngest children. Our "reverse parade" afforded our families and faculty to see one another again. Teachers went more than "the extra mile." The return to in-person instruction in September 2020 was enthusiastically met by everyone. Alternatives such as remote instruction and Hy-flex models were made available for those who were not ready to return in-person. The reopening team had spent the entire summer making plans for reopening which followed the guidance provided by the NYS Department of Education, Governor Cuomo and the Department of Health. The quidelines were being constantly changed and the team responded. Confident in our plan, we reopened. Ninety percent of our students returned to our building and 10% chose virtual learning.

Financially, Covid-19 produced drastic effects on our school. Fundraisers were halted. Some families in our PreSchool pulled their children. Other families experienced a significant decrease in income as the business world responded to the pandemic. Summer programs were cancelled. Additional revenues including rental of our facility disappeared. Churches were closed; thereby eliminating financial support to the school as they struggled to address the many issues brought about by the pandemic. The end result was a deficit of \$264,618 for the 2019-2020 school year. Without the benefit of the Payroll Protection Program and some of our savings, we would have been unable to address that deficit.

As we returned to school for the 2020-2021 school year we continued to face financial challenges. With all the extra protocols in place to keep our facility healthy and safe for our students and faculty, expenses skyrocketed. Reorganization of classrooms, reduced class sizes, increased demand for soap, hand sanitizer, paper towels, electrostatic foggers—some of which were in limited supply—produced unexpected expenses. In addition, our building was not (and is not) available for outside use, thereby reducing potential rental income as well as opportunities to gather as a school community. CARES funds were reallocated and resulted in a lower amount than originally anticipated.

How did we do? As we near the end of this school year, we have been blest. We have been able to keep our school open to provide in-person instruction and remote instruction for the entire school year (with very limited quarantines necessary). Our students have adjusted well to mask-wearing, hand washing, and social distancing guidelines. Behind those masks, we know there are smiles. Everyone is glad to be together again. Our teachers continue to give their all under trying situations. Our students have moved throughout the building in "pods" in order to reduce risks. It is not an ideal situation. Yet, our students have been able to continue to grow in faith and knowledge. As we end this year and plan for the 2021-2022 school year, we hope to return to "normal." Hope allows us to look toward a brighter tomorrow. We continue to await further guidance from New York State as we make our plans.
